SUBJECT: The Bureaucrat, Inc., Copyright Procedures

Thank you for submitting a paper for publication by The Bureaucrat, Inc. (TBI), in *The Public Manager* (TPM). TBI policy is to own the copyright on all TPM publications to protect the interests of TBI, its authors, and their employers, and at the same time to facilitate the appropriate reuse of this material by others.

United States copyright law requires that the transfer of copyright of each contribution from the author to TBI be confirmed in writing. As a condition of publication, authors must sign the TBI Copyright Transfer Agreement and return it with the manuscript to the Publisher at the address on the form or send it via e-mail in PDF format.

If you are employed and prepared your paper as part of your job, the rights to your paper may initially rest with your employer. In that case, when you sign the TBI form, we assume that you are authorized to do so by your employer. If not, the form should be signed by an authorized person (see **Section A: Agreement to Transfer**).

For jointly authored papers, an original signature is required from one (assumed senior) author only. However, we assume that all authors have been advised and have consented to the terms of this form and this single author acts as duly authorized agent of the others.

Government employees who prepared the work as part of their job, and whose work is not subject to copyright, are not required to sign, but all coauthors outside the government are so required. If any or all authors are government employees, or the work was performed exclusively for a government agency, please sign **Section B: Confirmation of Government Work**.

In the case of a work performed under a government contract or grant, TBI recognizes that the government has royalty-free permission to reproduce all or portions of the work and to authorize others to do so, for official government purposes only, if the contract or grant so requires. Authors employed by a civilian agency working under government contract are required to sign both Sections A and B.

Reuse of third-party material contained in TBI-copyrighted works always requires the consent of the copyright holder, as TBI's copyright does not cover third-party material.

NOTE: If the manuscript is not accepted by TBI or is withdrawn prior to acceptance by TBI, this transfer will be null and void and the form will be returned to the author.
